#### A. PRESENTATIONS

On October 18, 2019, the County Superintendent received a resolution (the petition) from the Banning City Council requesting the transfer of approximately 1,528 acres of uninhabited territory from Beaumont Unified School District to Banning Unified School District. The purpose of this preliminary hearing is for the County Committee to either grant or deny the petition. If the petition is denied, it goes no further. If it is granted, the County Committee must adopt a tentative recommendation and hold one or more additional public hearings in the area proposed for transfer. Additionally, as the process moves forward more research on the impact of the transfer will be required, including an environmental assessment and/or an EIR. In order to provide information for the Committee to make this decision, RCOE retained the services of School Services of California, Inc. to prepare a feasibility study of the nine conditions that must be met pursuant to Education Code Section 35753 for the transfer to be approved. A copy of this study has been provided to the Committee members, the Banning City Council, both school districts, and interested parties.
