B. PRESENTATIONS

Education Code Section 1002 requires the County Committee on School District Organization to approve adjustments in the trustee areas of the County Board of Education following each decennial federal census to make them as nearly equal in population as practicable. The Riverside County Board of Education has considered trustee area adjustments to achieve this purpose based on demographic data analysis provided by Redistricting Partners at its regular meeting on November 3, 2021, and at a public hearing on November 17, 2021. The County Board developed a recommended plan for adjusting its trustee areas at its November 17, 2021, meeting. Redistricting Partners will present this redistricting plan for the County Committee's consideration. Following the presentation, a Public Hearing will be held on this matter.

C. PUBLIC HEARING

The County Committee on School District Organization will conduct a public hearing regarding the redistricting and demographic study following the 2020 census and the proposed redistricting plan recommended by the Riverside County Board of Education.
