#### A. PRESENTATIONS

On October 18, 2019, the County Superintendent received a resolution (the petition) from the Banning City Council requesting the transfer of approximately 1,528 acres of uninhabited territory from Beaumont Unified School District to Banning Unified School District. The County Committee held a preliminary hearing on the petition, pursuant to Education Code section 35721, on September 24, 2021. The County Committee held two votes (one to deny the petition and one to approve the petition), yet neither motion was approved by a majority of the County Committee. Elliott Duchon and Jack Clarke will review the school district organization process and status of the petition.
