Plan Summary 2023-24

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Temecula Valley Charter School is one of the oldest charter schools in the state. It was founded in 1996 by a group of parents because they felt their children's needs were not being met in the neighborhood public schools at that time. They wrote a charter addressing these primary tenets: hands-on learning that extends beyond the classroom, an opportunity for students to work across age levels, exposure and experience with a foreign language, community service, and mandatory active parent participation.

Today, public schools in the Temecula Valley systems understand that these tenets are simply good practice and so many of these are also a part of the wider area education environment. The entire valley is full of high performing schools and good STEM programs. Temecula Valley Charter School, like other charters, is tasked with remaining relevant and creating a market for itself. How does TVCS stand out and create a niche while remaining true to the intent of the charter?

At TVCS, students are provided opportunities to experience not only the best teachers trained in the best practices for their core instruction, but also visual arts, performing arts, dance, science, technology, one-to-one technology, a hands on science lab, multiple field trips for every grade level, advanced math (Algebra), advanced language arts, and strong parental participation. We believe we can provide the opportunity for students to find their passion and their genius. We can facilitate growth and success in areas that the public schools typically do not provide. Our arts program is second to none. It is proving to be an increasingly unique commodity in the area as traditional public schools are being squeezed by legal and financial obligations.

In the spirit of public education, TVCS provides an inclusive environment. TVCS is continually working to improve and increase access to the curriculum for all students. TVCS is involved in ongoing improvement and implementation of a Multi Tiered System of Supports, Child Find efforts, Positive Behavior Supports, Evidence-based practices in intervention, and the highest quality Special Education program we can build. Our program provides an opportunity for all students; most importantly in the low socioeconomic and English Language Learner subgroups, to access a high quality program tuition free. Additionally, our assessment of incoming Transitional Kindergarteners and Kindergarteners provides the earliest opportunity to identify students with disabilities.

We believe that TVCS is demonstrating the value of the arts programs in education. Our students experience instruction in all of these programs throughout the year, yet, with the significant demand on instruction time we continue to maintain academic scores that meet or exceed the very high bar set by schools in this area. Through our comprehensive multi tiered system of supports, early identification and intervention practices, and broad and enriching curriculum, our students overall are demonstrating a high rate of social-emotional development and academic success.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

While the pandemic has continued to have a marked impact on student achievement across California, students at TVCS significantly outperformed state averages on all Dashboard metrics. All of our school's student subgroups, except for students with disabilities, were in the 'medium' or 'high' performance range in English Language Arts (ELA) and overall our students scored 24.9 points above standard. In addition, most of our student groups performed in the 'medium' range on the math standards. This compares well to statewide averages where most students fall into the 'low' performance category for both ELA and math.

While the TVCS chronic absenteeism rate of 10% is elevated since the pandemic and is much higher than usual for our school, this rate compares very favorably in comparison to the statewide average of 30%. Furthermore, our 0% suspension rate is as low as possible and again compares very favorably to the statewide average of 3.1%.

Reflections: Identified Need

Despite significant gains we have made since the pandemic in getting our lowest performing students back toward grade level, the impact of the pandemic continues to negatively effect student performance. In particular, student outcomes in math still significantly lag behind pre-pandemic results. All of our student groups (not just one or two) are experiencing lower academic achievement results. While we know this phenomenon is not unique to our school, we nevertheless will continue our intervention

strategies to work toward eliminating these skill gaps.

When analyzing the performance of our student groups, our economically disadvantaged students in particular are demonstrating lower performance than most student groups in ELA, math, and chronic absenteeism. In addition to the LCAP strategies we have formulated, we will also be ensuring next year that our teachers are coordinating with the staff of our after school ELOP program so that our economically disadvantaged students are receiving extra academic supports.

The school's success in keeping student groups out of the 'very low' and 'low' performance ranges in ELA can be attributed to both the strong emphasis on ELA classroom instruction and our reading intervention program. With our math scores lagging behind our ELA scores, we will be placing a greater emphasis on our student math interventions and supports.

While our school has always provided a calm, nurturing environment for our students, we will continue to emphasize social and emotional learning and our PBIS strategies so that our student behaviors incidents continue to improve toward pre-pandemic levels.

Engaging Educational Partners

TVCS uses a variety of strategies to engage our educational partners and get feedback on our programs. We do this through a variety of in-person and online formats that allow our educational partners to provide thoughtful input. In-person engagement includes informal discussions with parents on a daily as administration talks with students, parents, and staff during student pick-up and drop-off times and throughout the day. Monthly morning parent meetings allows the administration to provide updates to parents about things happening at the school and receive parent ideas and suggestions on how we can improve our school. Similarly, monthly teacher and staff meetings allow for a regular exchange of ideas.

For each of our educational partners (parents, students, teachers, and staff) we have customized surveys that we send out on an annual basis. These surveys solicit feedback on a wide variety of topics including: the quality of instruction, quality/availability of school learning materials, school climate, school facilities, etc. The results of these surveys are compiled and analyzed so that school leaders can identify and address any areas of concern.

TVCS also promotes participation at our monthly board meetings. Board meetings are advertised in numerous ways and parents, students, and community members are encouraged to attend and speak at board meetings. Because our board is comprised of several TVCS parents who connect with other parents on a regular basis, our board is closely attuned to the needs of our students and families.

A summary of the feedback provided by specific educational partners.

Each year we analyze the feedback we receive from our educational partners. Below are some key points to summarize some of that feedback:

Parents: parent feedback generally indicated positive feelings about the quality of teachers and instruction, the care and respect staff show students, and the academic supports available to students. The lowest rated areas were related to student behavior on campus, including how well students treat

each other and how well they follow school rules.

Students: students praised the quality of teaching on campus and the quality of academic supports. As with parents, the lowest rated areas were related to student behavior on campus, including how well students treat each other and how well they follow school rules. Both the parent and student feedback reinforces our need for our LCAP goal #1, which is to ensure a safe, welcoming, and inclusive school climate.

Faculty: teacher feedback showed high levels of satisfaction with the ability to meet the learning needs of students, the quality of instructional materials, as well as the frequency and quality of their interaction with parents. In contrast, teachers rated professional development the lowest on the annual survey. This is an area that will require attention, because our LCAP goal #2 goal of providing high quality classroom instruction is dependent on the continuous growth and improvement of teachers.

Staff: staff members at TVCS reported having positive interactions with students and parents but did not rate highly the quality of the school's facilities. Improving our facilities will help us in achieving our LCAP goal #1 of maintaining a safe and welcoming school environment.

In addition, parents, faculty, and staff members expressed that they would like to see improvements in the frequency and timeliness of school communications. This directly impacts our ability to reach our LCAP goal #3, which is to improve stakeholder engagement.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

Based on the feedback from our educational partners and their areas of highest priority described previously, it is clear that the school needs to continue to make improvements on our current LCAP goals: 1) ensure a safe, welcoming, and inclusive climates 2) provide high quality classroom instruction and curriculum 3) support and encourage the stakeholder engagement process. For this reason, TVCS will not be altering its current goals, but will continue working and adjusting strategies to ensure that those goals are met.

While some of the trainings were done in-house rather than outsourced, all of the planned actions were implemented.

For action #3, the Fountas and Pinnell training, the training was done in-house by TVCS personnel so money was not spent on the company's training program.

For action #4, the All Access Literacy Support training, the training was done by TVCS personnel so money was not spent on the company's training program.

An explanation of how effective the specific actions were in making progress toward the goal.

Because so many students had fallen behind grade level in math and many student arriving new to our school were several grades behind in math, using an adaptive math program, Freckle, to target gaps in student math skills was helpful. While our math scores are still below where we'd like them to be, we could see students were making progress. Even more effective, however, was our reading intervention program (ROAR), that is conducted by several intervention specialists. We have found that having instructor led interventions is even more effective than computer program based interventions.

Next year we will be shifting the focus of some of our staff training. We will continue training on serving EL students and will add training to support the school's new writing program, Writing by Design. We will also be exploring options to see if we can duplicate the success of our reading intervention program with math intervention.

TVCS has one less than 1% foster youth, approximately 5% English Learners, and approximately 15% low-income students. Using this data, we prioritized goals and actions that would help meet the needs of these student groups even if those goals and actions were provided for all students. For example, one of our actions to support instruction is maintaining a math instructional aide. Because foster youth, EL students and low income students typically perform below other student groups in math, we knew that maintaining a math instructional aide would be especially beneficial to these students and therefore prioritized the action and the resources needed to support that action.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

TVCS has determined that the most efficient use of funds is to provide supplemental services in a school-wide manner ensuring that all students including the targeted student population receive support. Although supplemental services will be implemented in a schoolwide manner, TVCS will proportionally fund the projects with supplemental funds and the remainder with general LCFF funds to include all students.

In an effort to meet both State priority areas for supplemental educational services for Unduplicated Pupils and the LCAP goals, the following schoolwide actions/services will be reassessed for effectiveness and implemented to support all students, but specifically Unduplicated Pupils.

Action 2.2 and 2.5 (Intervention/Enrichment Curriculum Support-Freckle and Professional Development for Freckle) - This additional system and training will give our Low-Income students and English learners access to systems of support to address learning loss experienced during the COVID-19 shutdown. Of course, this will serve to benefit all students as well.

Action 2.6 (Math and Literacy Tutoring) - TVCS enacted this in response to the needs of our families, primarily Low-income and English Learner families. We will offer additional time for these students, either before or after school, to access credentialed teachers or qualified aides for additional academic support. Again, this will be available to all students as needed, but it is primarily aimed at Low-income students and English Learners.

Action 2.7 (ELD Support) - We desire to see our EL students succeed and work toward reclassification. With this in mind, we will bolster our ELD supports through support materials, ongoing training for EL support providers, and a stipend (or stipends) for additional services.

However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically

disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students.

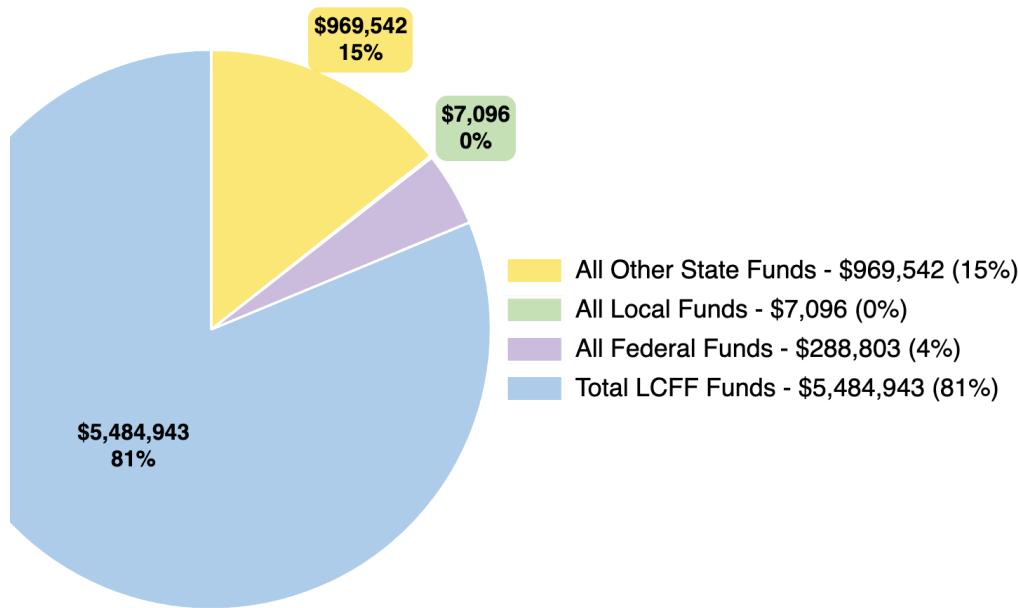

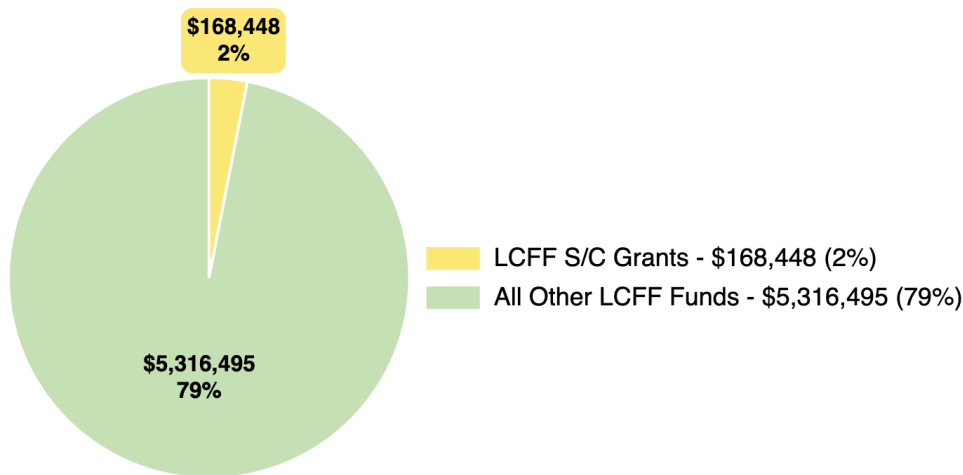
Budget Overview for the 2023-24 LCAP Year

Breakdown of Total LCFF Funds



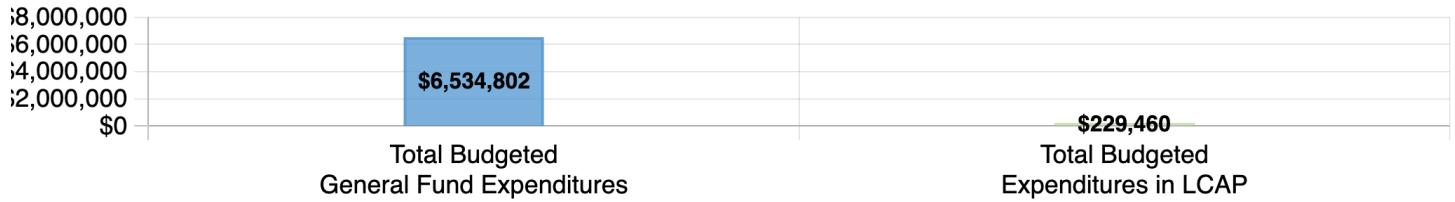

These charts show the total general purpose revenue Temecula Valley Charter School expects to receive in the coming year from all sources.

The total revenue projected for Temecula Valley Charter School is \$6,750,384, of which \$5,484,943 is Local Control Funding Formula (LCFF), \$969,542 is other state funds, \$7,096 is local funds, and \$288,803 is federal funds. Of the \$5,484,943 in LCFF Funds, \$168,448 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.

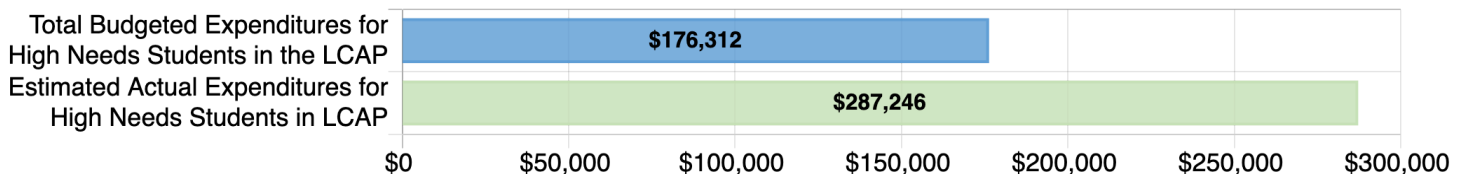
