Instructional Leader	 With an administrative assignment. Industry experience (3,000 hours). Possess a Clear Administrative Services Credential (CASC). Possesses a Clear Teaching Credential (General Education or Education Specialist). 3,000 hours may be a combination of education and industry experience. Note: Candidates will receive a Designated Subjects CTE Teaching Credential, not the Supervision and Coordination Credential. 	1 semester
